		(b) The children of a registered worker, laid off during downsizing shall be fully entitled for free education in WWS for a period of six month or the completion of academic year, whichever is greater.	
		(c) If a student of WWS leaves school for Hifz-e-Quran, he / she shall be accommodated in the respective school as per his / her age/grade. The provisions of above cited sub-clauses shall also apply on him/her.	
III	19. If a student fails in three subjects in annual exam, he will not be promoted to next class.	19. If a student fails in three subjects in annual exam, he / she will not be promoted to next class. However, the result of PEC for class V&VIII (33% passing marks) shall be acceptable for promotion to next class.
